He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who are related as mentioned above. PAN. relevant work order including completion certificate will be enclosed along with tender application form separately for each work. The original certificates will have to be produce at the time of issue of the tender paper. Late tenders will be summarily rejected.
