- Specification and Make: Quotation should be given for the exact specification and make as shown in the enquiry against SI.
 No. of the item., if in the view of the supplier there is any other alternative item which can serve out purpose, quotation may
 also be given for the same separately client list along with the order copy of similar equipment supplied to any CSIR Lab / any
 Govt. Organization including detail of price & all charges must be attached.
- Mode of dispatch: RATE SHOULD BE QUOTED FOR ANY OF THE FOLLOWING MODE OF DELIVERY, For Import: By Air or Sea on FCA/FOB Basis (i) for Dispatching Station [to be specified]. Detail of up gradation work

Up gradation of the machine is to be done to computerized the machine so that data acquisition can be done automatically in the computer. Up gradation kits consists the following items:

- a) Pressure Transducer with pressure as per required MPa
- b) Precision encoder 0.1 mm to measure the displacement
- c) LCD Panel to display Load and Elongation
- d) Software

NOTE:

- a) Pressure Transducer of equivalent capacity is to be provided to sense the mechanical force in terms of electrical signal and onward transmission to highly precise transducer
- b) The resolution of the encoder should be minimum 0.1 mm
- c) LCD Panel consists the followings:
 - i) It should be micro controller based
 - ii) 16 characters, 2 line, Minimum 100 x 23 mm (approx) in size, blue white or black green LCD display
 - iii) In built overload display
 - iv) Computer or Laptop is to be connected optically
 - v) Data recording capacity minimum 50 samples per second, Least count (minimum) total capacity /20000.
 - vi) 'Unit of load in Kg or KN can be selected from panel
 - vii) Facility for on board extensometer for using 25 mm extensometer with 1 micron resolution.
- d) Software consists the followings:
 - Software should support tensile test and data acquisition can be done through LCD panel.
 - II) Latest window based software and user friendly
 - III) should give all displays & keyboards so that need not to touch panel.
 - IV) Manual data can be processed
 - V) Test report can be prepared and stored
 - VI) Data can be analysed with load vs elongation graph.
