INSTRUCTIONS TO THE CANDIDATES PROVISIONALLY SHORTLISTED FOR APPEARING IN THE INTERVIEW

1. The shortlisted candidates should report to the CSIR-Central Institute of Mining & Fuel Research, Barwa Road, Dhanbad as per the above schedule with Admit Card-cum-Interview Hall Ticket alongwith proof of identity such as AADHAR card/voter photo identity card/Driving License/Passport/PAN Card etc. The Admit Card will be collected from the candidates, hence it is suggested that copy of the same may kindly be kept for your future reference.

2. Candidates must bring the following documents, as applicable in original along-with self attested photo copies of each.

- a) SSLC/Matric/Xth Std Certificate
- b) SSLC/Matric/Xth Marksheet
- c) 10+2/Intermediate /Diploma Certificate
- d) 10+2/Intermediate /Diploma Mark sheet
- e) BE/B.Tech/Graduation certificate
- f) BE/B.Tech/Graduation Mark sheets(each semester)
- g) Certificates in respect of all other educational/professional qualification including experience as mentioned in the application form.
- h) Testimonials mentioned by you in your application form, if any.
- i) Rules/Guidelines issued by the Board./Inst./University for converting CGPA/DGPA/OGPA or any other such grading into percentage of marks.**
- m) Original Caste/Category Certificates (SC/ST/PWD) in the prescribed formats.
- n) OBC certificate wherever applicable, has to be latest valid certificate (not older than 1 year) in the format prescribed by Govt. of India indicating that the candidate belongs to the non-creamy layer.

The set of self attested copies of the documents will be kept in this Institute for future reference.

3. In case the candidate serving under Central/State Govt./Autonomous Body/PSU, No Objection Certificate from the present employer to appear for Interview will be required to be submitted by them. If the Permission/No Objection Certificate is not submitted at the time of verification of the documents, the candidate will not be allowed to appear for the same.

4. The Candidates may ensure that they fulfil the conditions/qualifications of the aforesaid advt. as well as the short listing/screening criteria adopted. Candidates will not allowed to be present for Interview if it is found during the verification of documents that he/she is not eligible for the post

applied for as per the advertisement/Screening criteria adopted. The onus is on the candidate to prove that all the information provided/submitted by him/her in the application form is true.
