1. The List of candidates shortlisted provisionally for appearing for trade test with Short listing/ Screening criteria has already been hoisted on the Institute's Website.
2. All the representation received within due date against list of shortlisted candidates have been disposed off and accordingly candidates have been informed individually through email.
3. The shortlisted candidates should report to the CSIR-Central Institute of Mining & Fuel Research, Barwa Road, Dhanbad as per the above schedule with Admit Card-cum Hall Ticket(in original) alongwith proof of identity such as AADHAR Card/voter photo identity card/Driving License/Passport/PAN Card etc.
4. Candidates must bring the following documents in original alongwith Admit Card-cum Hall Ticket otherwise you may not be allowed to appear for the Trade Test.
  - a) SSLC/Matric/Xth Std Certificate
  - b) SSLC/Matric/Xth Marksheet
  - c) 10+2/Intermediate /Diploma Certificate
  - d) 10+2/Intermediate /Diploma Mark sheet
  - e) Graduation Mark sheets
  - f) Graduation Certificate
  - g) Experience Certificate (If any)
- One set of self-attested photo copies of all the above certificates/ID proof is required to be submitted at the time of verification.

In case the candidate serving under Central/State Govt./Autonomous Body/PSU, No Objection Certificate from the present employer to appear in Trade Test will be required to be submitted by them. **If the Permission/No Objection Certificate is not submitted at the time of verification of the documents, the candidate will not be allowed to appear for the same.**
6. The Candidates may ensure that they fulfill the conditions/qualifications of the aforesaid advt. as well as the short listing/screening criteria adopted. Candidates **will not allowed to be present for Trade Test if it is found during the verification of documents that he/she is not eligible for the post applied for as per the advertisement/Screening criteria adopted. The onus is on the candidate to prove that all the information provided/submitted by him/her in the application form is true.**
